Interested bidders may get the bidding document from "Engineering & Development Wing, Sheikh Zayed Medical College/Hospital, Victoria House, 32-A Businessman Colony, Rahim Yar Khan" on submission of written application and a copy of CNIC along with payment of non-refundable fee of Rs. 1000/- (one thousand only) for each bidding document including detailed specification and terms & conditions from **22-09-2011 to 29-09-2011** during office hours.
2. Single- Stage – Two Envelops bidding procedure shall be applied. The envelops shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters. The Financial Proposal of bids found technically non-responsive shall be returned unopened to the respective bidders.
3. Sealed bids are required to be brought in person by the authorized representative of the interested bidder on or before **20-10-2011** by 11:00 AM positively. The bids received till the stipulated date & time shall be opened on **20-10-2011** at 11:30 AM in the presence of the bidders or their authorized representatives.
4. The bidders are required to submit the company profile including Technical, Engineering, Managerial capabilities, after-sale services and past Experience/Performance along with their Technical Bid.
5. The bidders are required to give their best and most competitive prices for the equipment.
6. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
7. The Procuring Agency shall incur no liability, solely by virtue of its invoking Clause (6) towards suppliers or contractors who have submitted bids or proposals.
8. Notice of the rejection of all bids or proposals shall be given promptly to all suppliers or contractors that submitted bids or proposals.
9. Procurements shall be governed by the Punjab Procurement Rules 2009.
